To be retained by each Member.

Use of the Buy Local Norfolk logo

Only current, registered Members of Buy Local Norfolk are licensed to use the logo, and then only within strict accordance with the terms & conditions of membership and these terms of use of logo.

It is a condition of use that the mark shall not be used without indicating that it is a collective mark

Members acknowledge that ownership of the logo shall remain at all times with Buy Local Norfolk and Members acknowledge that they shall not acquire any interest in the logo save to the extent permitted by these terms.

Use of the logo by Members is limited to the context that it:

1. signifies that they are a business entity which is a current Member of the scheme 'Buy Local Norfolk'
2. means the Member is a business entity which satisfies the criteria for membership and is therefore a business that is truly local and independent to Norfolk, England.

The logo must not be used in any other context. It is important to note that the logo must not be used to imply or suggest quality, sponsorship or endorsement of any goods and/or services.

Each Member of Buy Local Norfolk is encouraged to display the Buy Local Norfolk logo on relevant business material belonging to that Member; this may include, but is not limited to, printed and electronic media.

Members agree to indemnify Buy Local Norfolk against all losses and costs suffered by Buy Local Norfolk on an indemnity basis (including, but not limited to, reasonable administrative and legal costs) resulting from any misuse by that Member of the logo and/or failure to adhere to the values associated with the brand Buy Local Norfolk.
